

State Reports on Redistricting Criteria

In the summer of 2022, we collected state reports on state legislative and congressional redistricting criteria from the 2021 cycle. For states in which we were not able to locate any reports, we reached out to a state official or staffer to confirm that none were publicly available.

Files are named by state, whether the metrics apply to the House, Senate, both (“legislative”), and/or congressional maps, and what criteria reports the file contains. Some states issue lengthy reports that include several criteria; these are identified as “reports.”

For example, the file “FL_senate_county_splits.pdf” contains a report on counties split by Florida’s Senate map.
