Election results validated for every candidate statewide?

No

At the statewide total level, the election results did not match VEST's in 13 races, with a maximum difference of 17 total votes. VEST's totals matched those of CT's election summary report

(https://authoring.ct.gov/-/media/SOTS/ElectionServices/StatementOfVote PDFs/2 018-SOV.pdf) in all races except for G18TREOWRI, where VEST reports 30 votes and the state reports 2,196.

Because VEST's totals match those of CT's election summary report, we believe there are minor errors in the precinct-level data we received from the CT SOS.

Election results validated for every candidate by county?

At the county total level, the election results did not match VEST's. VEST's totals matched those of CT's election summary report

(https://authoring.ct.gov/-/media/SOTS/ElectionServices/StatementOfVote PDFs/2 018-SOV.pdf) for all races and counties except for G18TREOWRI in Hartford County, where VEST reports 13, while the state reports 2,179.

These differing votes seem to be coming from Keeney School in the town of Manchester and Robertson School in the town of Manchester, where W. Michael Downes (the write-in candidate) received 1235 and 931 votes respectively. Outside of these two precincts, the most votes Downes received in a precinct was 6, so these appear to be mistakes, although they do appear in the official results.

Election results validated for every candidate by precinct?

No

At the precinct level, the election results did not match VEST's (727 out of 742 precincts matched). The maximum vote difference between precincts is 9 votes and the average difference is 2.3 votes. A full list of the 15 precincts can be found in the validation notebook. All but three of the cases of differing votes occur when the source file has zero votes for a particular candidate, so the file we received appears to have some missing data.

In comparing against CT's election summary report (https://ctemspublic.pcctg.net/#/report), it appears as though VEST is correct in the case of these differences.

Trivial name changes were required to join the source election results to VEST's file.
