Election results validated for every candidate by county?

At the county total level, the election results matched VEST's. The county totals also matched those of Nebraska's election summary reports.

Election results validated for every candidate by precinct? At the precinct level, the election results did not match VEST's (1335 out of 1353* precincts matched).

Significant name changes were required in a few counties in order to match source election results to VEST (e.g., Gage, Hall, and Fillmore counties). Trivial/no name changes required for the remaining precincts.

Of the 18 unmatched precincts

- 14 are unremarkable single-vote variances in Sarpy County; these are caused by absentee allocation differences between RDH and VEST.
- The remaining four discrepancies are in York County. The votes in each of these precincts has been assigned to a VEST boundary that does not match up with NE SOS's vote assignments.
- Because NE SOS and VEST both agree on the total number of votes cast in each of these four precincts, this appears to be a clerical error in VEST's results.

Because NE SOS and VEST both agree on the total number of votes cast in each of these four precincts, this inconsistency is likely due to a clerical error; it does not point to a systematic problem with VEST's data.

*Precinct validation was not performed on the 26 precincts within Custer County due to inconsistencies between the precinct data from county-level elections officials, NE SOS, and VEST. Custer County changed the names and numbers of their precincts before the 2020 election, and VEST's precinct labels do not account for this, which makes their data difficult to validate. More information from the county level has been requested in order to validate Custer County's precinct-level data.
