Election results validated for every candidate by county? No	At the county total level, the election results did not match VEST's. There was a difference of two votes for G20PRERTRU in Garrett County and differences in 14 counties for G20PREOWRI, ranging from two fewer votes in VEST's file to 119 more votes in VEST's file. Based on the fact that VEST's G20PREOWRI total is closer to the state's official number than ours, it appears as though VEST corrected some mistakes in the precinct-level vote file. VEST's totals also did not match those of MD's election summary report (https://elections.maryland.gov/elections/2020/results/general/gen_results_2020_4_001html) with a difference of one vote for G20PREOWRI in Calvert County.
